

Minutes of a Special Meeting of the Justice Committee

The Justice Committee of the McLean County Board met on Tuesday, April 18, 2006 at 8:30 a.m. in Room 400 of the Government Center, 115 E. Washington Street, Bloomington, Illinois.

Members Present: Chairman Renner, Members Owens, Rackauskas and Harding

Chairman Renner called the meeting to order at 8:40 a.m.

Chairman Renner presented two action items for the Stand-up Committee. The first is a request for approval of the Renewal of a Child Support Enforcement Grant (IV-D Program) from the Illinois Department of Healthcare and Family Services – Intergovernmental Agreement No. 2005-55-008 for the Circuit Court. Mr. Will Scanlon, Trial Court Administrator, explained that this is the second year of a three year grant. He stated that no matching funds are necessary. Mr. Scanlon indicated that the Grant funds the salary of a Hearing Officer for the Child Support Enforcement program.

Motion by Rackauskas/Owens to Recommend Approval of the Renewal of a Child Support Enforcement Grant (IV-D Program) from the Illinois Department of Healthcare and Family Services – Intergovernmental Agreement No. 2005-55-008 for the Circuit Court.

Motion carried.

Chairman Renner presented a request for approval to accept a Juvenile Accountability Incentive Block Grant (JAIBG) from the Illinois Criminal Justice Information Authority for Court Services. Mr. Dave Goldberg, Director, Juvenile Detention Center, reported that funds from this grant will allow McLean County to send a team of four professionals to the National Juvenile Services Training Institute in Indianapolis, Indiana in June. He noted that there is a 10% cash match of \$297.00 and the grant is \$2,976.00.
