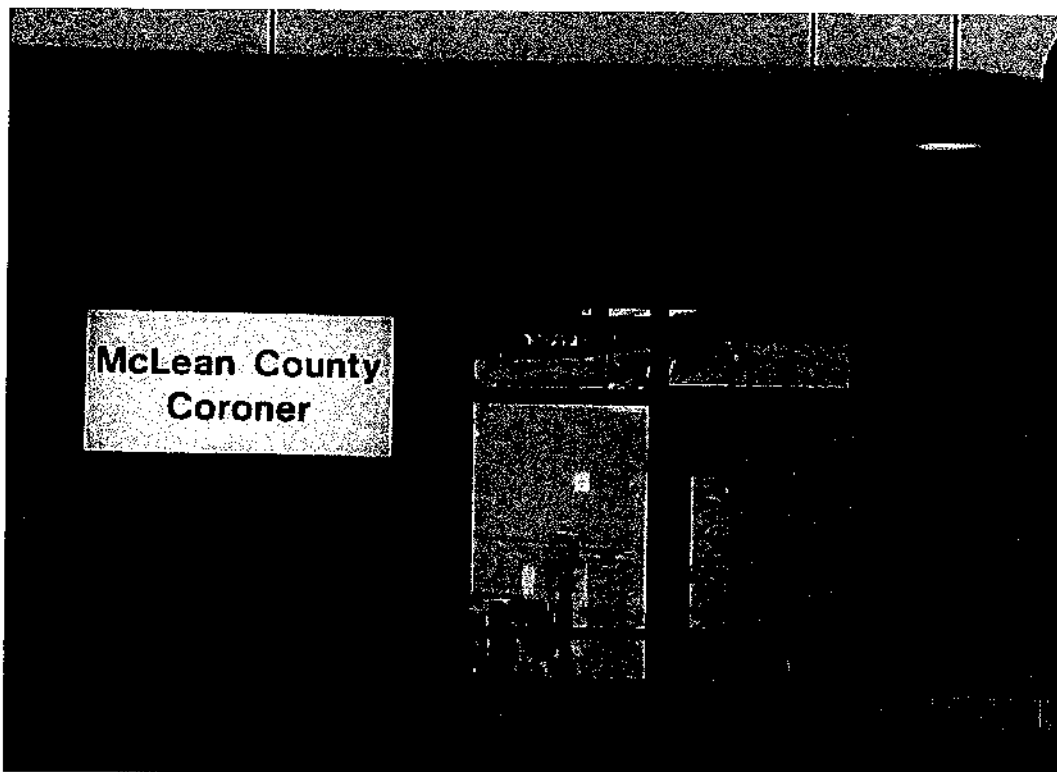

**2002 Year End Report**



The McLean County Coroner's Office is a county office that, even with imposed budget restrictions, must remain in operation twenty-four hours per day, seven days per week. The figures compiled for this annual report provide the citizens of McLean County, our local news media, and the general public with beneficial information concerning the investigations and activities of the Coroner's Office during the year 2002. ## **Introduction**

The year 2002 was another record setting year for the McLean County Coroner's Office. Recall that in 2001, not only did the Coroner's Office have the highest number of deaths reported at 802, but the Office also performed the highest number of autopsies in history with a total caseload of 100. In 2002, the total number of deaths reported to the Coroner decreased to 772, however, the number of autopsies performed rose to 110.

Not all deaths reported to the Coroner result in an autopsy being performed. It is the Coroner who makes the ultimate decision, and this decision is made after a review of the initial investigation. Once the initial Coroner's investigation is complete, the Illinois State Statutes provide guidance and describe the circumstances under which an autopsy is to be performed. These circumstances are as follows:

- Where a death has occurred and the circumstances concerning the death are suspicious, obscure, mysterious, or otherwise unexplained and in the opinion of the examining physician or the Coroner the cause of death cannot be established definitely except by autopsy, and where a death has occurred while being pursued, apprehended or taken into custody by or while in the custody of any law enforcement agency, it is declared that the public interest requires an autopsy be performed, and it shall be the duty and responsibility of the Coroner to cause an autopsy to be performed (55 ILCS 5/3-3015).
- Where an infant under 2 years of age has died suddenly and unexpectedly and the circumstances surrounding the death are unexplained, an autopsy shall be performed (55 ILCS 5/3-3016).
- The Coroner shall make a preliminary investigation into the circumstances of the death and attempt to ascertain the cause of death, either by autopsy or otherwise in the following situations (55 ILCS 5/3-3013):
  1. A sudden or violent death;
  2. A maternal or fetal death due to abortion or a sex crime;
  3. A death where the circumstances are suspicious, obscure, mysterious, or otherwise unexplained, or where in the written opinion of the attending physician, the cause of death is not determined;

4. A death where addiction to alcohol or to any drug may have been a contributory cause; or
5. A death where the decedent was not attended by a licensed physician.

Attached, as Appendix A, is a list of all 110 autopsies performed by the McLean County Coroner's Office in 2002. The list includes the age and sex of the decedent, Coroner Kimmerling's reason for performing an autopsy, the autopsy results, and inquest results (if necessary). Compare Appendix A with the above-mentioned guidelines, and one will find that all autopsies performed in McLean County were from mandated scenarios.

Thirty-six of the 110 autopsies performed resulted in natural deaths. The two most often seen causes of death in these persons were coronary atherosclerosis (narrowing of the coronary arteries due to plaque formation) and/or hypertensive cardiovascular disease (an enlarged heart due to high blood pressure) – causes of death that are preventable.

### **Why the increase?**

The increase in cases that warrant additional investigative effort, including scheduling of autopsies, may be attributed to community factors such as increased population and a change in age demographics. The following population statistics are from the U.S. Census Bureau:

McLean County Population (1990-2000): 16.5% increase  
 City of Bloomington Population (1990-2000): 25% increase  
 Town of Normal Population (1990-2000): 13% increase

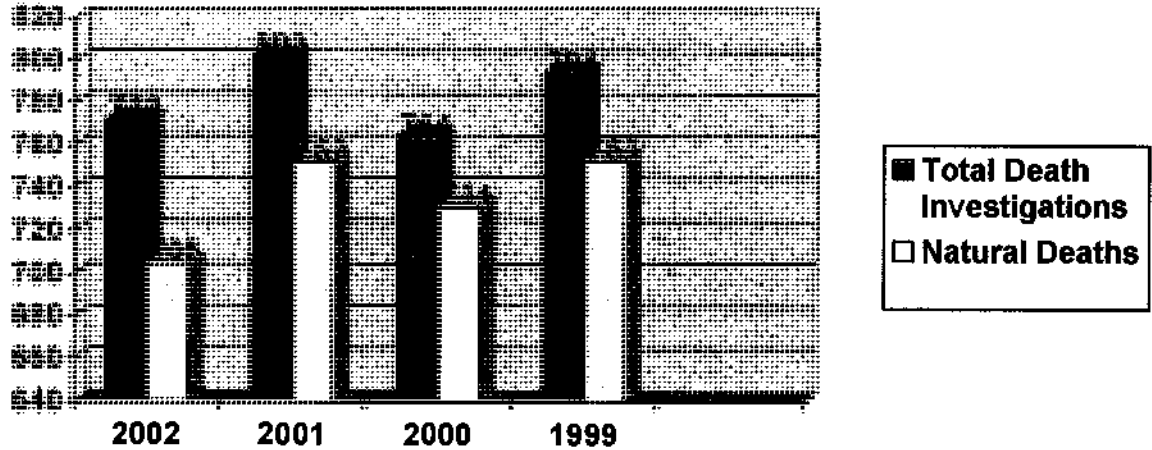
Although McLean County's population grew by only 16.5 percent, Bloomington-Normal's population grew by 38 percent. As such, this community has experienced an increase in deaths typically seen in an urban setting, e.g., gang related shootings, drug overdoses, pedestrian vs. motorvehicle incidents, etc.

From 1990 to 2000, McLean County also saw a change in the age of its residents. Significant changes were seen in three age ranges, and those ages, according to the U.S. Census Bureau, are:

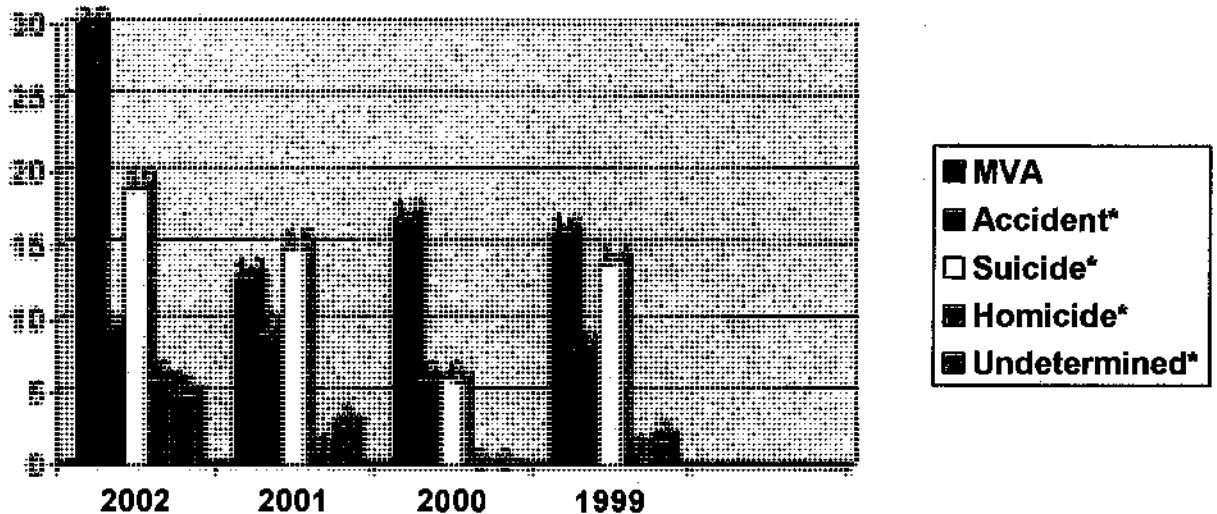

According to Appendix A, forty-percent of the 110 autopsies performed in 2002 fell into the above three age ranges.

### Manner of Death Classification



In 2002, there were 67 non-natural deaths -- deaths requiring a Coroner's Inquest to determine cause and manner -- compared to 50 in 2001 (see above chart). If the manner of death is not natural, then it falls into one of the following categories: homicide, suicide, accidental (including motor vehicle incidents), or undetermined. The chart below shows the trends in non-natural deaths:



\* Please note that these 2002 totals are subject to change. There are 8 pending cases from the year 2002.

Of the 26 fatalities involving the driver and/or passenger of a motorized vehicle, 17 of the victims were not wearing seatbelts. Alcohol and/or drugs were involved in 27 percent (or 8 out of 30) of the motor vehicle deaths. Five of the 30 motor vehicle deaths involved someone age 16 or younger.

### **Accidental Deaths \* (9 total)**

The drugs involved in the overdose deaths include various combinations of alcohol, cocaine, heroin, methamphetamine, and tramadol (prescription analgesic). Seven of the victims were male and 2 were female. The aviation incident occurred at Central Illinois Regional Airport and involved a twin engine Beech King airplane that crashed killing the pilot and his passenger.

### **Suicides \* (19 total)**

McLean County continues to experience a high rate of deaths by suicide. Twelve of the suicide victims were male; 7 victims were female. The age range for victims was 21 to 82 years old. Whereas the trend in 2001 was that the majority of victims were middle-aged males who were newly separated and/or divorced and experiencing financial problems, the trend this year indicates that the majority of victims were men *and* women who were either physically or psychologically ill and were having difficulty coping with their illnesses.

#### *Special Section: McLean County Survivors of Suicide*

Chief Deputy Coroner Barb Nafziger has been instrumental in assisting local therapists with a support group for those families who have lost a loved one to suicide. This group meets twice per month, and the purpose of the group is to provide support to anyone who is grieving over a suicidal death. Deputy Nafziger has agreed to be a community point of contact for this group.

A Coroner's jury shall rule a death a homicide when the evidence indicates that a person took another person's life with some intent. Reckless homicide, involuntary manslaughter, or second degree murder are not options in the Coroner's system. Although all six homicide victims died within McLean County, one victim sustained her injuries in Livingston County. Four homicide victims were male and two were female.

Five deaths were ruled as undetermined for the year 2002. An undetermined manner of death occurs when a Coroner's jury at the inquest could not clearly determine the circumstances surrounding the death (either evidence was open to doubt or deliberation was inconclusive). For example, whether the gunshot wound was intentional or accidental. Three out of these 5 deaths were related to heroin use.

#### *Special Section: Infant Deaths (3 total)*

During the year 2002, McLean County experienced 3 infant deaths (a child less than one year old) compared to 5 infant deaths in 2001. The first infant death of 2002 fell under suspicious circumstances for he was the third infant to die in his family within a short period of time. After a thorough investigation which involved the Bloomington Police Department, the Coroner's Office, and the State's Attorney's Office, a Coroner's jury ruled his death as undetermined cause and undetermined manner. The second infant death was attributed to congenital heart disease, and the third infant death is a pending 2002 case within the office.

### **Miscellaneous Coroner's Office Items**

- The office issued 121 death certificates and signed 259 cremation permits. The Coroner must sign all cremations as a final check and balance, and as such, the County receives \$10 for every permit signed.

- Coroner Kimmerling conducted 67 inquests in 2002, with pending inquest cases. Again, these 8 cases are not reflected in this year end report.
- The youthful DUI program, a joint program between the Coroner's Office and Court Services, had 48 juvenile offenders make initial contact with our office and enter the program. Another 53 offenders successfully completed the program. There were 3 completion classes held in the year 2002.
- The Diversionary Program for Juvenile Probation has grown from a quarterly program to monthly scheduled tours of the Coroner's Office. In 2002, there were 7 classes held with a total of 59 participants. In 2001, the program had 70 participants. There were 2 repeat offenders sentenced to 10 days of community service within the Coroner's Office.
- The Coroner's Office referred 22 cases to the American Red Cross, 9 cases to the Regional Organ Bank of Illinois (ROBI), and 22 cases to the Galley Eye Bank for tissue and/or organ donations.
- Alzheimer's research continues on a limited basis. Currently, there are 15 persons enrolled in this brain procurement program. Three individuals donated their brains for Alzheimer's research in 2002.

### **Morgue Management**

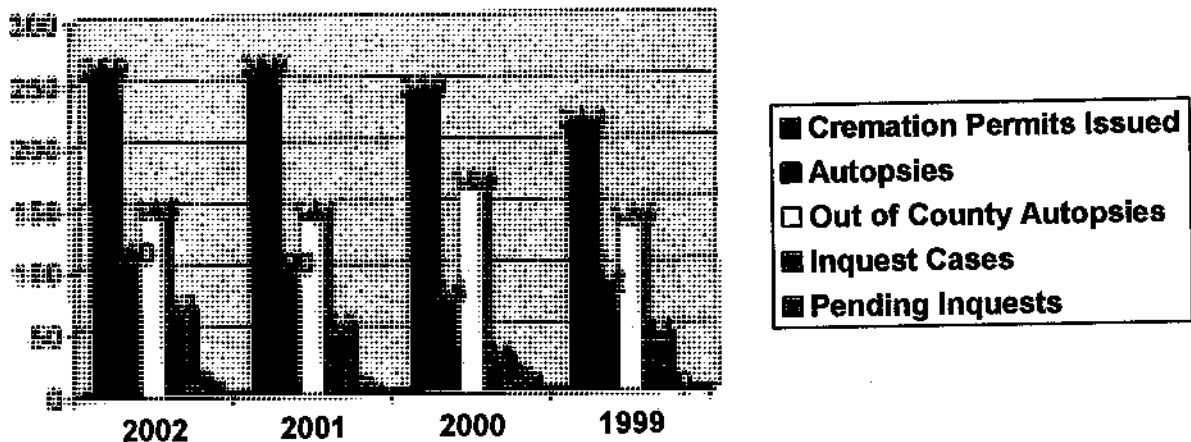
McLean County autopsies are at an all time high for the second consecutive year. As such, managing the morgue with imposed budget restrictions has been difficult. Most significantly, Peoria County is currently without a pathologist, and McLean County is providing assistance until further notice.

The following chart illustrates the past four year trend in McLean County autopsies compared to out of county autopsies, the number of cremation permits



signed, and the number of inquests held.

### Education/Public Service

One of the Coroner's goals set for 2002 was to visit all McLean County Nursing Homes and review with them their procedures for Coroner's Office notifications. These visits over a six-month period reinforced a positive working relationship with area health care agencies. Coroner Kimmerling's goal for 2003 will be to visit with all area Fire and Emergency Medical Service agencies in order to review basic death investigation protocol.

Autopsy viewing experiences were offered to all three nursing programs in the area, and several students from Illinois Wesleyan University and Illinois State University took advantage of this opportunity.

During 2002, Coroner Kimmerling was honored to speak at many different organizations. The topics of her talks ranged from the Coroner's role within the community to Forensic Nursing to why a career as Coroner. These groups included:

Deputies Nafziger and Knight gave informational talks to health classes at Normal Community High School, Emergency Medical Technician classes at Heartland Community College, nursing students at Illinois State University, and a local suicide support group. Additionally Deputy Nafziger represented the Coroner's Office at the Illinois Wesleyan Intern Fair.

During 2002, the following groups toured the Coroner's Office and became reacquainted with the role of the Coroner within the community:

- Normal Police Department's Government Day
- Illinois State University's Death & Dying class
- Driver's Education programs, including classes from Central Catholic High School, Gridley High School, LeRoy High School, and Reeder's Driving School
- Bloomington High School Health Occupation class
- Tri-Valley Sociology/Psychology class
- Normal Community/Normal West High School class
- Juvenile Court Services Diversionary Program
- Calvary Baptist's Anatomy & Physiology class

One of the most unique tours in 2002 was held in conjunction with the McLean County Chamber of Commerce. Coroner Kimmerling offered the office to be part of the Chamber's Business Before Hours tour during the month of October. In an hour and one-half, more than 80 business people from the community came to the office to socialize, speak with Coroner's Office staff members, and tour the morgue.

### **Personnel Changes**

The end of 2002 brought changes to the Coroner's Office. Chief Deputy Coroner Tony Becker resigned from the County on December 16<sup>th</sup> 2002 in order to pursue an opportunity with the Illinois Law Enforcement Training and Standards Board in Springfield, Illinois. Shortly after his departure, Coroner Kimmerling named Barb Nafziger Acting Chief Deputy.

Permanent changes were made within the office at the end of the County's hiring freeze. Coroner Beth Kimmerling, Chief Deputy Coroner Barb Nafziger, Deputy Coroner Steve Knight, and Deputy Coroner David Killian staff the office on a full-time basis. David worked for the office in a part-time capacity for the past two years and is now training in the full-time position.

New to the office in 2002 is Administrative Deputy Coroner Judy Mowery who assists the office on a part-time basis three days per week. Judy brings to the Coroner's Office 29 years of administrative experience and 15 years of EMS experience.

Primary part-time Deputy Coroners or Deputies who take call at least once per month, include Sarah Dick, Dan Duncan, Gary Morefield, and Randy Wikoff. Randy is new to the office and brings with him 15 years of law enforcement experience. Back-up Deputy Coroners or Deputies in outlying areas who assist the office when a death occurs in his or her community, include Deb Phares (Gridley), Mike O'Grady (Hudson), RD Johnson (LeRoy), Larry Shindel (Carlock), David Leach (McLean), Eric Crabtree (Bloomington Township), and Larry Milby (Downs).

### **Training**

The Coroner's Office continued with its goal of having all primary staff complete the American Board of Medicolegal Death Investigators' (ABMDI) certification process (<http://www.slu.edu/organizations/abmdi/certification.shtml>). David Killian and Sarah Dick successfully passed the examination process this past year. To date, all full-time staff and two out of the four primary part-time Deputy Coroners are Registered Death Investigators.

During the year 2002, members of the Coroner's Office were able to attend specialized investigative schools and accumulate continuing education credits to keep their certification current. Coroner Kimmerling attended the Mid-states I.A.I. Divisions Educational Conference entitled "Multi-Discipline Education in the Forensic Sciences" in Peoria in March 2002. She also participated in the well-respected "Reid Technique of Interviewing and Interrogation" class held in Bloomington in May 2002.

In January 2002, then Deputy Nafziger attended a "Bereavement Ministry Workshop" course in Springfield. She also attended a training class with part-time Deputy Coroner Morefield that was sponsored by the Norfolk Southern Police Department. This class was held in April 2002 and was entitled "Grade Crossing Collision Investigation". Her final training class was a local PATH Crisis Intervention Seminar held in Bloomington in November 2002. Deputy Nafziger's

future training goals include pursuing additional bereavement seminars and completing her formal education in criminal justice and/or sociology.

Deputy Knight attended the training program "Medical Death Investigation" in November 2002. This class was held in Springfield and was sponsored by the Public Agency Training Council. With the loss of Tony Becker's experience in Accident Reconstruction, Deputy Knight has expressed an interest in attending a future training seminar on this topic.

Newly promoted Deputy Killian did not attend any outside training opportunities in 2002. However, his future training interests are crime scene investigation and field interviewing and interrogation.

Part-time staff has indicated an interest in more formal training and addressing this request will be a goal of 2003.

The highest daily total occurred on December 24, 2002 and was due to the snow storm that occurred that day. Many of the calls were crashes due to road conditions.

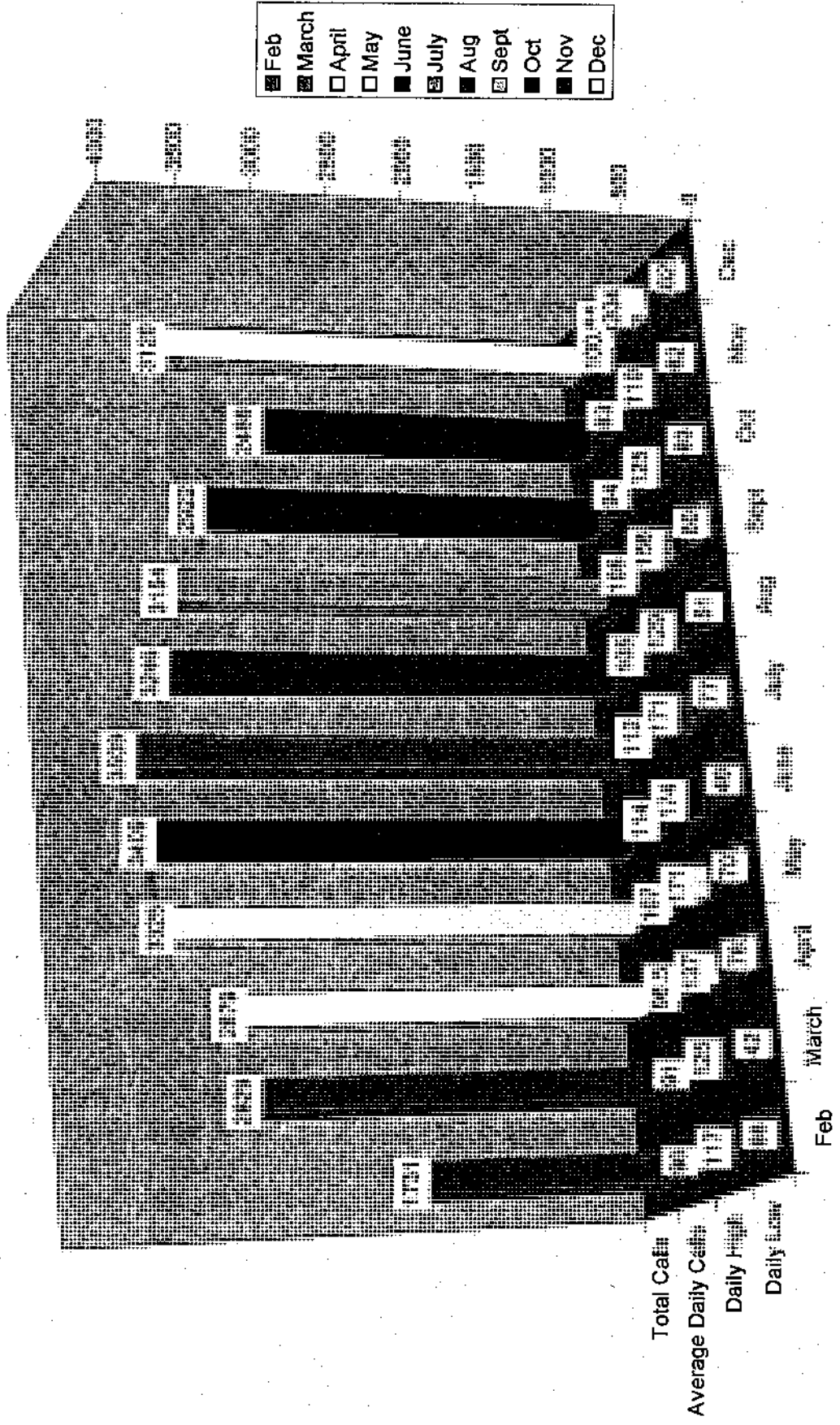

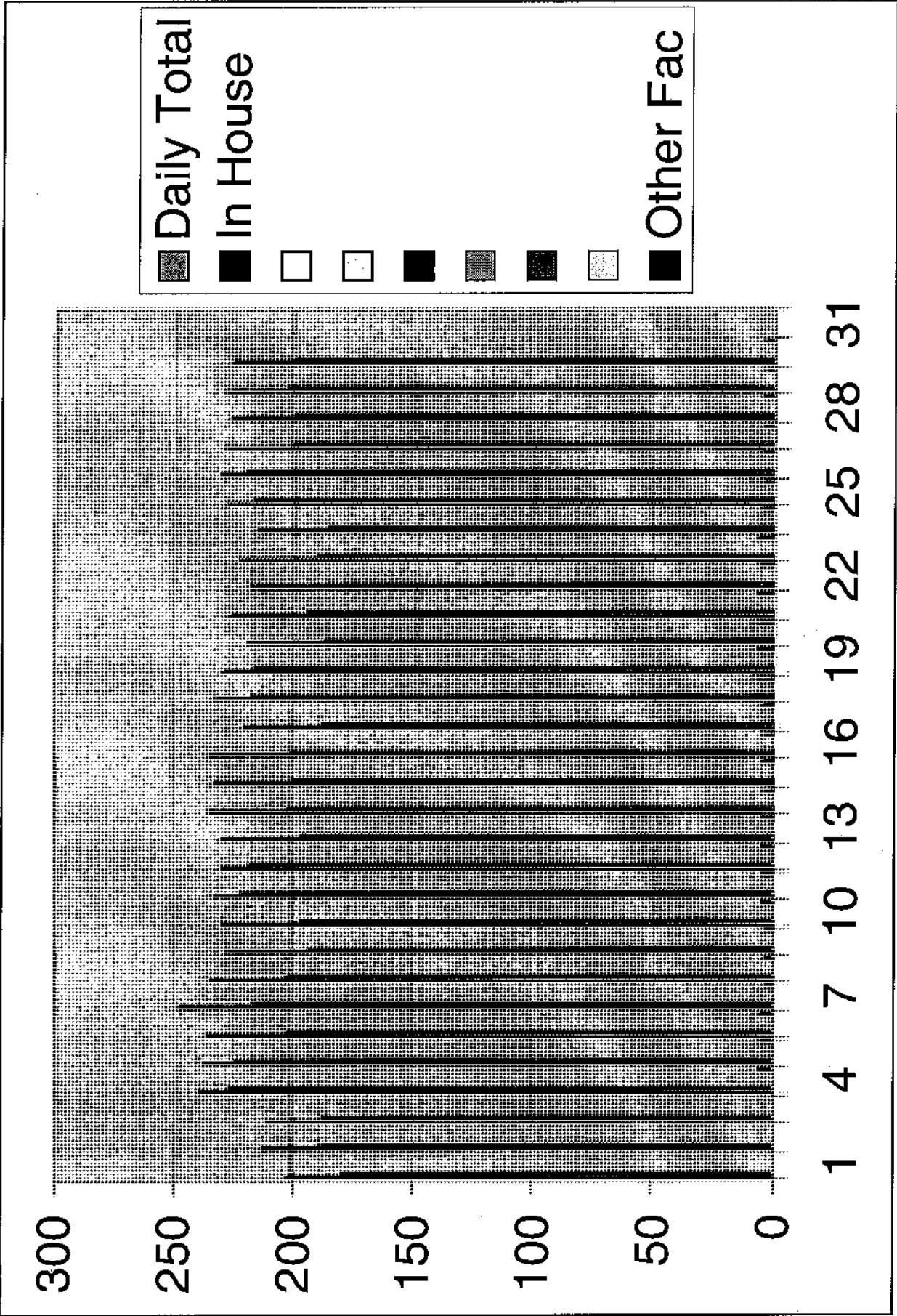

**INTERGOVERNMENTAL AGREEMENT BETWEEN  
THE VILLAGE OF HEYWORTH AND McLEAN COUNTY  
TO IMPLEMENT AND SUPPORT AN INTEGRATED  
JUSTICE INFORMATION SYSTEM**

**WHEREAS, the Village of Heyworth (hereinafter the Village) is a municipal corporation and pursuant to Article VII, Section 10, of the Illinois Constitution is permitted to enter into Intergovernmental Agreements to obtain or share services with the County; and**

**WHEREAS, McLean County (hereinafter the County) is a body politic and corporate and pursuant to Article VII, Section 10, of the Illinois Constitution is permitted to enter into Intergovernmental Agreements to obtain or share services with the Village; and**

**WHEREAS, the Village and the County deem it to be in the best interests of the citizens of all of McLean County to enter into an Intergovernmental Agreement which sets forth the cooperative efforts and understandings that can be provided by the Village and the County to implement and support an Integrated Justice Information System (hereinafter the IJIS) which will provide essential law enforcement information and services to the Village and the County; now, therefore**

**IT IS HEREBY AGREED AS FOLLOWS:**

**The County shall:**

- 1. Be responsible for the initial IJIS software and upgrade costs, as well as any future system wide upgrades or enhancements, in consideration of the Village agreeing to utilize the IJIS for entry of all Village police incident crime reports.**
- 2. Provide system administration, network administration, database administration and security administration to support the IJIS software and database.**
- 3. Control any changes to the IJIS software. To enhance the cooperative work effort between the Village and the County, along with representatives of other system users, an IJIS Work Group consisting of representatives from the County, other system users and the Village shall be appointed to review, approve, and prioritize any fixes and enhancements to the IJIS software and database and then to see that the updated IJIS software is distributed to all IJIS users.**
- 4. Provide the following levels of service on a best efforts basis:**

**The IJIS software and database will be available at a 95% level, 7 days per week, 24 hours per day.**

Page 2

The IJIS software and database will be available 7 days per week, 24 hours per day with the exception of two (2) hour maintenance segments of a two (2) hour duration each scheduled monthly with advance notice to the IJIS Work Group.

When it is necessary to upgrade the operating system and/or the ORACLE software and/or the database, it may be necessary to use an alternate system which may have less functional capability than IJIS.

Catastrophes such as hardware failure and/or loss of power beyond the capacity of the universal power supply can and will occur. Availability and restoration of the IJIS will be provided as soon as possible.

No liability will be attributed to the County for not meeting the above service levels unless failure of system is caused by negligent acts or omissions of the County or failure on the part of the County to properly maintain those components of the system under its obligation to maintain. If the County or its employees are negligent, then damages recoverable by the Village will be limited to actual damages incurred. The County shall, upon request, provide the Village with evidence of general liability insurance coverage in the minimum amount of \$1 million per occurrence.

5. Provide an IJIS Master Name Records function which will include name collapse, delete and expungements of master name entries.
6. Protect all data and software applications from unauthorized access, accidental disclosure, modification, and/or destruction and release data only in accordance with law.

The Village shall:

1. Be responsible for the cost, installation, and maintenance of the computer hardware and communication networks required to access the IJIS software application and database.
2. Be responsible for the cost of installation and maintenance of the IJIS software updates which are solely requested by the Village. This includes the updated required versions of the IJIS application software, the operating system software, and/or any support software.
3. Appoint at least one IJIS Security Administrator who shall be responsible for assigning and/or changing "passwords" and user identifications and, whenever necessary, defining user roles and responsibilities.

Provide and be responsible for maintenance telecommunication lines with a minimum data transmission speed of 56kbs to provide communications to/from the County. Where

- communication is initiated by the Village at a slower speed, the County reserves the right, at the sole discretion of its database administrator, to terminate the communication where that communication is or may be causing a negative impact upon the performance of the database or the system. The approach to the best pricing and payments for the communications links will be addressed outside of this Agreement.
5. Agree that the IJIS software is proprietary software which has been developed and licensed by TRW Technologies, Inc., 1999 Broadway, Suite 2000, Denver, Colorado 80202, for use by the County.
  6. Agree, as an IJIS user, not to disclose, copy, or change the IJIS software application or content to any other person, entity, municipality, or corporation, and to refrain from willfully damaging or losing data contained within the database, except as may be required by law.
  7. No liability will be attributed to the Village for not meeting its obligations hereunder unless failure is caused by negligent acts or omissions of the Village or the failure of the Village to properly maintain those components of the system under its obligation to maintain. If the Village or its employees are negligent, then damages recoverable by the County will be limited to actual damages incurred. The Village shall, upon request, provide the County with evidence of general liability insurance coverage in the minimum amount of \$1 million per occurrence.

The Village and the County shall:

1. Agree to utilize the ORACLE Discover ("Ad Hoc" query tool), unless otherwise determined by the IJIS Board, to develop and prepare local reports needed by the respective law enforcement agencies.
2. Agree that the IJIS software is licensed by TRW Technologies, Inc., 1999 Broadway, Suite 2000, Denver, Colorado 80202, to the County.
3. Agree to implement and enforce the IJIS Workstation Security Policy which is attached to this Agreement as Appendix A and, by reference, is hereby incorporated as a part of the Intergovernmental Agreement.

The Village and the County agree that:

1. This Intergovernmental Agreement shall be binding upon both parties until and unless amended by agreement of the parties, provided, however, that the County may unilaterally terminate this Agreement with 6 months notice and the Village may unilaterally terminate this Agreement with 6 months notice.
