**An EMERGENCY APPROPRIATION Ordinance
 Amending the McLean County Fiscal Year 2009
 Combined Annual Appropriation and Budget Ordinance
 County General Fund 0001, Facilities Management Department 0041**

WHEREAS, the McLean County Board, on November 18, 2008, adopted the Combined Annual Appropriation and Budget Ordinance, which sets forth the revenues and expenditures deemed necessary to meet and defray all legal liabilities and expenditures to be incurred by and against the County of McLean for the 2009 Fiscal Year beginning January 1, 2009 and ending December 31, 2009; and,

WHEREAS, the Combined Annual Appropriation and Budget Ordinance includes the operating budget for the Facilities Management Department; and,

WHEREAS, the McLean County Board, at its regular meeting on Tuesday, April 21, 2009, approved a resolution to make certain prudent budget adjustments, including cancellation of non-essential capital projects; and,

WHEREAS, funds have been identified to cover the costs of an emergency boiler replacement in the Courthouse and a portion of the costs to complete a project to install new Category 6 data cabling and other necessary related equipment in permanently installed cabling locations in the 3rd, 4th and 5th floors of the Law and Justice Center; and,

WHEREAS, \$289,127.00 in the Facilities Management Department budget is not obligated for any essential capital projects; and,

WHEREAS, the Property Committee at a meeting on May 7, 2009, and the Executive Committee, at a meeting on May 12, 2009, approved and recommended to the County Board an Emergency Appropriation Ordinance in the amount of \$289,127.00 to restore said unobligated funds to the General Fund Unappropriated Fund Balance; now therefore,

BE IT ORDAINED by the McLean County Board as follows:

1. That the County Auditor is directed to make the following Emergency Appropriation from the Facilities Management Department Budget to the County board's Unappropriated Fund Balance as follows:

Subj: **Emergency Replacement of Courthouse Boiler**

Late this past winter we noticed a leak in the old Courthouse boiler. Upon investigation it was determined that multiple cells in the boiler were leaking. Further investigation showed that the only repair, upon consultation with the manufacturer and local boiler specialists, was to turn the boiler off, unpack the cells, and determine how many cells were leaking. We suspected at least three of the nine cells were leaking.

To unpack the boiler in order to repair and replace any leaking cells would require the entire boiler be dismantled. The action of disassembling the boiler could cause more cells to suffer damage. The boiler was installed in April of 1994. The boiler serves as the main heating plant for the Mclean County Museum of History.

County staff met with County Administration and outlined the repairs needed to fix the boiler. We explained that, in our opinion and that of the professionals, the disassembly could either show more damage or the disassembly action could cause more damage. The cost of replacing the boiler in its entirety was approaching the cost of replacing just the leaking cells. All of the nine cells of the boiler are the same age. The boiler was off warranty. It was decided that the boiler needed to be replaced under an emergency basis. The gas burner, controls, and other non-boiler parts could easily be removed and reinstalled on a replacement boiler. The budget amount needed to replace the boiler was \$33,600.00. County Administration approved the emergency replacement of the boiler. The original boiler cost \$36,400.00 in 1994.

The new Weil-McLain steam operated boiler, model number BG-988-SF, was ordered. This boiler is the boiler the building has been configured to accept. County staff removed the old boiler and discovered six of the nine cells were corroded through. The room was prepared for acceptance of the new boiler in April 2009. The new boiler was installed and completed on May 1, 2009.
