Subj: Replacement Exterior Sign for Fairview Campus

Early this year the Property Committee asked me to investigate replacing the ground mounted exterior sign at the Fairview Campus with a new, larger sign. The Committee then reviewed a larger, easier-to-read sign design, which we had approved by the Town of Normal sign code enforcement officials. The Town of Normal officials approved the larger sign to be 16' wide by 7' high (standing on 3' supports).

We then wrote bid specifications and mailed them to ten (10) area sign firms. We also advertised the Request for Bid notice in the periodical of general distribution (the Pantagraph).

As specified, a bid opening was conducted on Friday, March 24, 2006. A total of three bids were received and opened in a public bid opening at the Law and Justice Center. Enclosed, please find a copy of the Bid Tabulation Sheet and a copy of all three bids. The low bidder was Fast Signs, 2109 N. Veterans Parkway, Suite 6, Bloomington, Illinois in the amount of \$10,774.50.

All three firms are reputable firms. Therefore, we would like to request and recommend the low bid submitted by Fast Signs be approved for replacing the Fairview Campus Sign.

We discussed funding with Mr. John M. Zeunik, County Administrator who will make a recommendation to the Committee.

I am pleased to answer any questions.




