Chairman Caisley called the meeting to order at 8:45 a.m.

Chairman Caisley advised that at the Executive Committee meeting an objection was made to the Emergency Appropriation Ordinance Amending the McLean County Fiscal Year 2012 Combined Annual Appropriation and Budget Ordinance, General Fund 0001, EMA 0049/EMA Operations 0052 – County Administrator's Office. He indicated that the Telephone Services line item 0001-0047-0052 0795.0003 did not add up correctly. He called for a motion to reconsider the item.
