Chairman Sorensen called the meeting to order at 4:30 p.m.

Chairman Sorensen presented the minutes from the November 12, 2013 Executive Committee Meeting and the September 17, 2013 Stand-Up meeting for approval. Hearing no additions or corrections to those minutes, Chairman Sorensen advised that the minutes would stand approved as presented.

Chairman Sorensen presented the reappointments, appointments and resignations.

Motion by Segobiano/Owens to Recommend Approval of the Reappointments, Appointments and Resignations as Recommended by the Chairman.

Mr. Wasson presented the Fiscal Year 2014 Recommended Budget for the County Board (0001-0001).

Mr. Wasson advised that the County Board Budget corresponds with the review of the changes that were made by the appropriate oversight committees as they went through the budget process. He stated that the proposed Budget Ordinance for Fiscal Year 2014 includes the expenditure budgets for all funds and all departments. Mr. Wasson noted that the Property Tax Levy, which was initially proposed to increase by approximately \$152,000 and a small rate increase, has been reduced. He stated that, through Committee actions, the total Levy will now be reduced by \$29,589 and the rate will be reduced by .00071.

Chairman Sorensen expressed his appreciation of the efforts of the Oversight Committees, the Administrator's Office, and Department heads. He reminded the Committee that when the Recommended Budget was first introduced two months ago, it called for an overall tax rate increase, but, through the hard work of the Committees and management, that was brought back down.

Mr. Segobiano stated that McLean County, under the leadership of Chairman Sorensen, and through the efforts of the Committees, the County Administrator's Office, and Department Heads, the County has done a good job with this budget and we can go to the taxpayers with all good faith and say that we have done due diligence, particularly as compared to what other local governments are proposing.

Mr. Wasson distributed a substitute "Fiscal Year 2014 Combined Annual Appropriation and Budget Ordinance." He indicated that the Department totals are the same as received in the packet, but the numbers in the packet are summarized by classification level. Mr. Wasson stated that we have, historically, presented the Budget Ordinance by department level only. This substitute report breaks it down by classification. He advised that this is being done this year because of a recent Public Act that requires additional details in the Budget Ordinance.

Mr. Segobiano asked if this will help to eliminate any Freedom of Information requests. Mr. Wasson replied that this whole Ordinance will be posted on the website.

Mr. Wasson advised that the last two pages, Attachment "A" are information on the County's indebtedness obligations, which are also additional items that are now required to be included.

Mr. Gordon suggested that this information also be provided at the County Board meeting next week.

Chairman Sorensen stated that this was a good budget packet this year.

Mr. Hoselton commented that the documents and the manner in which they were handled is the best that he has seen since serving on this Committee. He thanked Mr. Wasson and the Oversight Committees.

Mr. Owens asked how the Administrator's Office fairs with the FOIA requests. Mr. Wasson replied that a vast majority of FOIAs come through the Administrators Office for initial review and distribution to Departments. He indicated that about 50% of the FOIAs are "run of the mill" requests that are received on a regular basis. The other 50% require legal review to make sure that we comply with the statute and to determine that certain information is not inappropriately released, which is time-consuming.

Chairman Sorensen asked that the Administrator's Office provide a report on FOIA requests, including how many are for commercial purposes. Mr. Wasson replied that a breakdown of departmental FOIAs can be provided to the Board members.

Mr. Segobiano recommended that the local and state legislators find a mechanism in which to charge for materials and staff time. Ms. Eisner noted that they did enact charges for commercial requests. Mr. Wasson stated that they have worked actively each legislative session over the last three years with both Metro Counties and the County's legislative consultant to identify ways to minimize the burden while maintaining transparency for our citizens, and will continue to do that.

Chairman Sorensen presented the October 31, 2013 bills and a transfer of \$10,000 within the Information Technologies Department as recommended and transmitted by the County Auditor for payment. The Fund Total is \$618,665.10 and the Prepaid Total is the same.
