

Minutes of the Special Transportation Committee

The Transportation Committee of the McLean County Board met on Tuesday, September 16, 2014 at 8:00 a.m. in Room 400, Government Center, 115 East Washington Street, Bloomington, Illinois.

Chairman Soeldner called the meeting to order at 8:55 a.m. He found a quorum present.

Chairman Soeldner presented the first item for action, Resolution and Bid Tab for the September 10, 2014 Letting for one (1) County 2014 MFT Construction Project, one (1) Township Non-MFT Construction Project and one (1) Township TBP Construction Project.

Mr. Schmitt reported that the Hudson Stuckey Road – CH 12 bid came in 12% under the estimate. The Lawndale Township Bridge bid was 13% over the estimate. The Martin Township Bridge was 5% over the estimate. He noted that the overestimate costs are due to increase in prices and the short time frame for the projects.
