Vice Chairman Wendt called the meeting to order at 4:30 p.m. and declared a quorum.

Vice Chairman Wendt presented for approval the minutes from the May 2, 2017

Mr. Jon Sandage, Sheriff, presented for action a request to approve an Agreement with Axon Enterprises, Inc. for the purchase of Taser equipment. He indicated this agreement is to replace all 21 Tasers are 12 years old and can no longer be serviced.

Motion by Schafer/Selzer to recommend approval of the agreement with Axon Enterprises, Inc. for the purchase of Taser equipment.

Mr. Sandage presented his monthly reports. Vice Chairman Wendt asked if there were any questions regarding the Sheriff's reports; hearing none, he thanked Mr. Sandage.

Mr. Chambers presented his monthly reports. Mr. Selzer asked if there is a pattern to some of the violence. Mr. Chambers indicated things go in waves. He indicated that there are really just a few members in the community who cause many of the issues and when they are prosecuted and in the Department of Corrections, things are quiet. Vice Chairman Wendt asked the Committee if they had any additional questions for the State's Attorney; hearing none, he thanked Mr. Chambers.

Mr. Wasson presented on behalf of Ms. Cassy Taylor, Director of Court Services a request to approve an Emergency Appropriation Ordinance amending the McLean county Fiscal Year 2017 combined annual appropriation and budget ordinance for Fund 0024 – General Fund Court Services.

Ms. Kathy Davis, Coroner presented her monthly and annual reports. Vice Chairman Wendt asked if there were any questions from the Committee; hearing none, he thanked Ms. Davis.

Vice Chairman Wendt indicated that Ms. Brucker was not going to be present and if the Committee had any questions they could ask her later or see if Mr. Wasson could answer their questions. Mr. Wendt asked if anyone had any questions, hearing none he moved on to the Circuit Clerk.

Mr. Everhart presented his monthly reports. Vice Chairman Wendt asked if there were any questions for Mr. Everhart; hearing none, he thanked Mr. Everhart.

Mr. Wasson presented his monthly report on staffing. Vice Chairman Wendt asked if there were any questions or comments on this report; hearing none, he thanked Mr. Wasson.

Vice Chairman Wendt reminded the Committee of the July meeting on July 5<sup>th</sup> at 3:00 p.m. Vice Chairman presented the Justice Committee bills for review and approval as transmitted by the County Auditor.

Motion by Selzer/Murphy to approve the Justice Committee Bills as transmitted by the County Auditor with a prepaid total in the amount of \$484,266.60 as well as the transfer included in the Justice packet.

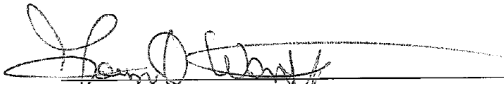

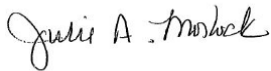
