Minutes of the Liquor Control Commission

The Liquor Control Commission of the McLean County Board met on Tuesday, September 3, 2019, at 4:15 p.m. in Room 404, Government Center, 115 E. Washington Street, Bloomington, Illinois.

Chairman McIntyre called the meeting to order 4:15 p.m.

Chairman McIntyre presented for approval the June 18, 2019 Liquor Control Commission Meeting Minutes.

Motion by Metsker/Schafer to recommend approval of the June 18, 2019 Liquor Control Commission Meeting Minutes.

Mr. McIntyre asked Ms. Metsker if she had a chance to follow up with Rudolph & Mary Hoffmann about White Oak Vineyards, Inc. Ms. Metsker indicated that the property had not been sold but wanted to keep license for now as they still have product to sell, and once the product is gone they will not renew the license.

Chairman McIntyre presented the Request for Approval of new Liquor License for KMDB d/b/a Merna Tap. Mr. Trevor Sierra handed out an updated spreadsheet that listed all businesses with liquor licenses approved by the McLean County Liquor Control Commission. He also handed out a list of product on site and pictures of location. He indicated the application before them requests a Class A license. He stated applicants met all requirements for the license including bond documentation and a clean background check. Mr. McIntyre asked Mr. Rich Marvel, attorney for KMDB, LLC to come forward. He asked him if the LLC had been established. Mr. Marvel indicated that paperwork had been approved with the State and LLC status granted. Ms. Schafer asked for clarification of the list Mr. Sierra passed out. He stated the list contains the new names, as he removed names approved in June. He stated that because we do not have a provision for transfer of a license they are applying for a new license as new owners.

Motion by Soeldner/Schafer to recommend approval of the new Liquor License for KMDB, LLC d/b/a Merna Tap.
