**RESOLUTION of the MCLEAN COUNTY BOARD  
DECLARING a LOCAL DISASTER**

WHEREAS, between June 25th and June 27th, 2021, areas of McLean County suffered from a series of thunderstorms that produced at times and in multiple locations up to 2” of rainfall per hour, up to 60 MPH winds, and penny to golf ball sized hail that caused isolated wind and hail damage, severe flooding and water damage to public and private property, disruption of utility services, and endangerment of health and safety of the citizens of McLean County, with every Township in the County being within the disaster area, and

WHEREAS, due to severe weather experienced in McLean County from June 25<sup>th</sup> through June 27<sup>th</sup>, 2021, McLean County has experienced a local disaster as defined by Illinois law; and

WHEREAS, pursuant to 20 ILCS 3305/11a Local Disaster was declared by McLean County Board Chairman John McIntyre for all of McLean County due to the June 25-27, 2021, storms, effective June 29, 2021 through July 6, 2021; and

WHEREAS, the effect of a declaration of a local disaster is to activate or continue to activate the McLean County Emergency Operations Plan providing for sharing of government resources and supporting any request of State or local agencies for assistance and to authorize the furnishing of aid and assistance to the same; and

WHEREAS, a Local Disaster shall not be continued or renewed for a period in excess of 7 days except by or with the consent of the governing board of the political subdivision; and

WHEREAS, due to continuing efforts to recover from the effects of the June 25-27, 2021 weather, the McLean County Board deems it appropriate to extend the Disaster Declaration beyond the initial seven-day period, and

NOW THEREFORE BE IT RESOLVED by the McLean County Board, now meeting in regular session, as follows:

- (1) The McLean County Board hereby declares that the Local Disaster declared by the County Board Chairman on June 29, 2021, be extended until July 16, 2021 for purposes of providing mutual aid in the clean-up of storm debris and damage assessment; and
- (2) The McLean County Administrator is directed to publish this Declaration pursuant to all applicable State and local laws.

This declaration is effective on July 6, 2021 and shall continue until July 16, 2021 unless extended by the County Board of McLean County, Illinois.
