Description: The McLean County Wind Energy Center (the Project) is located entirely in McLean County, Illinois, northeast of Bloomington-Normal, Illinois. The Project will be up to 250 megawatts (MW) in size, consisting of approximately as 100 General Electric (GE) (or equivalent) 2.5 MW and/or 2.3 MW wind turbines. The Project will power approximately 69,000 homes annually.

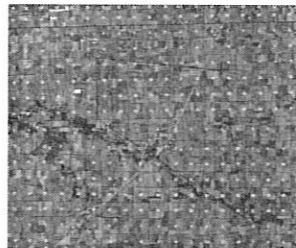
